This programme of ours has been started in the state of Jharkhand to educate the local underprivileged people and literate the people so that they can carry their lives little more comfortably without having to live merely to be deprived in every respect in life. We have appointed teachers and provided them note books, slates, slate-pencils, pens etc. for free distribution (vide the Report for 2009-2010). To run this programme we need about **Rs. 2 lacs (approx) per year including** 1) the salary of the teachers and coordinators, 2) the transport, 3) stationary and 4) miscellaneous management expenses in 8 (eight) such centers.
